





SPAIN



Through its subsidiary Autopistas, Abertis is one of the main operators of high-quality, high-capacity roads in Spain thanks to the 633 kilometres under management.

Autopistas manages 7 concessions throughout the country: Avasa, Aucat, Castellana, Aulesa, Autovía del Camino, Túnels and Trados and has a minority stake in a further Autema (48 km).

In recent years, Autopistas has conducted an in-depth review of its business to guide it towards more sustainable mobility

with innovation projects focused on rolling out advanced mobility management solutions, on renewing materials, installing electric charging stations on all its roads, and self-consumption of energy.

All the Autopistas group companies share the goal of providing customers with responsible management of the roads they operate and facilitating safe, comfortable and quality travel experiences on every journey.

FRANCE



Abertis' presence in France is channelled through Sanef, a concession group in which it holds a 100% stake. Sanef controls 22% of the country's total high-capacity network. It manages five of the seven toll road access routes to the Île de France (Paris region) and also traffic connecting Germany, Belgium and Luxembourg with the north of France.

France is Abertis' largest market, with a 36% contribution to Ebitda in 2023.

In recent years, Sanef has been carrying out an ambitious investment plan of nearly 600 million euros to improve its toll road network in France in exchange for an extension of the concession contracts. In addition, as part of its commitment to cleaner mobility, Sanef has installed 650 ultra-fast electric charging points distributed across all its service areas, as part of its sustainability strategy aimed at mitigating the effects of climate change and facilitating the transition to sustainable mobility.

ITALY



Abertis controls 91.64% of the Italian industrial group A4 Holding, whose main assets are the A4 Brescia - Padova and A31 toll roads.

A4 Holding operates 236 kilometres of toll roads, mostly in the Veneto region, one of Italy's most prosperous areas, with one of the country's highest levels of GDP and per capita income. It is a geographical area strategically located in the corridor connecting the industrial north of Italy with the economic centre of Europe.

The A4 Brescia – Padiva toll road runs a distance of 146 kilometres between Brescia and Padova With three lanes in each direction, it is one of the country's busiest toll roads. The 89 kilometre-long A31 (Autostrada della Valdastico)

BRAZIL



In Brazil, Abertis' subsidiary Arteris operates a total of 7 toll road concessions totalling more than 3,200 kilometres, consolidating its position as one of the largest toll road operators in the country.

It has a balanced portfolio of concessions divided between 2 concessionaires that report to the State of São Paulo, ViaPaulista and Intervias, and 5 others on the federal network - Fernão Dias, Regis Bittencourt, Litoral Sul, Planalto Sul and Fluminense.

In recent years, Arteris has been carrying out an extensive network expansion and improvement plan, having invested R\$17.6 billion between 2010 and 2023, including emblematic works such as the Contorno de Florianópolis in Santa Catarina.

Arteris has also made great efforts to improve road safety. In the decade 2010-2020, Arteris reduced fatalities by up to 50% on its roads, reaching the UN target for safer traffic.

CHILE



In Chile, Abertis is the largest toll road operator in traffic volume terms, and through its subsidiary VíasChile it manages 412 kilometres through four concessions in the Metropolitan and Valparaíso regions: Rutas del Pacífico, Autopista Los Libertadores and Autopista Los Andes; which connect Santiago with the country's main ports. It also operates the Autopista Central, the busiest urban toll road in Chile and the main connecting road of the country's capital.

VíasChile has finished transforming all of Santiago's access roads to barrier-free toll systems, a historic milestone which demonstrates its commitment to electronic tolling and to more efficient, convenient, cleaner and safer mobility.

Proof of this is that Autopista Central, which began operating in 2004, became the first urban concessioned highway in the Metropolitan Region, and with it Chile became a leader in Latin America when it began operating the free-flow electronic toll system and a pioneer worldwide in applying this system in an interoperable manner.

MEXICO





Abertis is present in Mexico through Red de Carreteras de Occidente (RCO), one of the country's largest toll road operators. RCO controls five concessionaires that manage eight toll roads and totaling more than 1.000 kilometres. Its toll road network is one of the most important in Mexico and forms the backbone of the road network in the central-west region, connecting its two largest cities, Mexico City and Guadalajara.

In 2020, the company reached an agreement with the government to invest in the country in exchange for a concession extension. RCO is set to more than 300 million euros in building three toll-free branch roads, in order to enhance mobility and safety in the states of Guanajuato, Michoacán and Jalisco.

ARGENTINA





In Argentina, Abertis manages two of the most important accesses to the city of Buenos Aires. Grupo Concesionario del Oeste (GCO) holds the concession for the Autopista del Oeste, which links the Federal Capital with the town of Luján; and Ausol holds the concession for the northern access, popularly known as the Panamericana highway, which includes the maintenance of the Autopista General Paz, an important ring road around the city.

Over the last few years, a comprehensive programme has been underway to enhance sustainability. Since 2022, 100% of electricity consumption is backed up by renewable sources, and they are the only road concessionaires in the country to do so. In addition, together the two companies manage 1,320 hectares of green areas along their routes, which represents a significant "green lung" for the 12 municipalities through which their roads run.

UNITED STATES





In the US, Abertis manages two concessions, Elizabeth River Crossings (ERC) in Portsmouth (Virginia) and Blueridge (Virginia) and Blueridge Transportation Group (BTG) in Houston (Texas).

ERC operates the Downtown Tunnel and the Midtown Tunnel as well as the Tunnel, as well as the non-toll extension of the Martin Luther King Expressway. Both tunnels operate under the barrier-free electronic tolling system and are two of the most and are two of the busiest lanes in the Hampton Road metropolitan area, providing an essential link across the Elizabeth River, connecting the cities of Portsmouth and Norfolk.

In 2023, Abertis acquired BTG, a 10.3-mile toll managed lane project on a 61-mile segment of the SH 288 in Harris County, Texas. The SH 288 links downtown Houston's major employment center and the Texas Medical Center with the fast-growing residential communities of Harris County and Brazoria County.



PUERTO RICO



Abertis is one of the main toll roads operators in Puerto Rico through Metropistas, the concessionaire that since 2011 has been operating the PR-5 and PR-22 toll roads, and which in December 2023 began operating the Island's other key roads, namely the PR-20, PR-52, PR-53 and PR-66, connecting more than 25 municipalities.

In collaboration with Emovis, an Abertis subsidiary that supplies toll technology, Metropistas manages its toll roads in an

innovative way, with electronic free-flow gantries allowing non-stop passage and a dynamic managed lane to alleviate congestion.

Abertis also fully owns Autopistas de Puerto Rico (APR), the company that holds the contract for the construction, maintenance and operation of the 2 km long Teodoro Moscoso Bridge over the San José Lagoon, which has connected San Juan with Isla Verde since 1994.

INDIA



In India, Abertis manages Isadak, which controls 100% of the concessionaire Jadcherla Expressways Private Limited (JEPL), which manages the NH-44; and 100% of Trichy Tollway Private Limited (TTPL), which holds the concession for the NH-38. These are two highways located in the states of Tamil Nadu and Telangana, both regions with economic growth above the average for India as a whole and with some of the highest GDP levels in the country.

The NH-38 highway is located in the state of Tamil Nadu, in the far south of the country. The state has seen its per capita income grow by

8% in the last decade and is also one of India's top tourist destinations.

This 94-kilometer-long corridor is a key corridor for the country and connects the industrial zones of Trichy and Madurai Trichy and Madurai with the state capital, Chennai. The NH-44 is located in the state of Telangana in south-central India. The toll road is part of the primary north-south traffic corridor and connects Hyderabad with Bangalore, the country's two main technology hubs. Fifty-eight kilometres long, it runs through a highly industrialised and commercial area.

The Abertis Foundation, based at Castellet Castle (Barcelona), was set up in 1999 as a non-profit organisation with the aim of contributing to the sustainable development of the different regions and countries in which Abertis operates. The Foundation's work focuses on five strategic lines: road safety, the environment, social outreach, culture and education.

One of its key pillars is sustainability and the environment and, specifically, the in-depth study of the Mediterranean region's ecosystems. This is formally enshrined in the Kingdom of Spain-Unesco alliance that materialised when this private partnership gave rise to the forest centre of its kind, namely, the International Centre for Mediterranean Biosphere Reserves.

In the social arena, the Abertis Foundation channels the Abertis Group's commitment to society through partnership agreements with leading national and international organisations.

It pays special attention to organisations engaged in promoting community involvement schemes, focusing on the most vulnerable groups in order to improve their quality of life and equal opportunities.

From day one, the Abertis Foundation has rolled out a far-ranging programme to promote culture, with the aim of bringing art within the reach of as many people as possible in the regions where Abertis operates. It also has its own projects to promote transport infrastructure management training and research through the International Network of Abertis Chairs on sustainable mobility.

In terms of road safety, it promotes actions aimed at road safety education for children, raising awareness among young people and accident prevention for older drivers.
